On behalf of the Board of Directors, I want to thank the Belleville area businesses and individuals who support Belleville CEO (Creating Entrepreneurial Opportunities). These leaders are extremely generous in providing our students with funding, expertise, meeting space, business tours, and one-on-one mentoring. The Belleville CEO program is funded by these individuals, businesses, and in partnership with District 201. Through this collaboration, the program celebrates its fourth year supporting two classes.

The CEO program is like no other. It is a real-world experience, exposing the students to numerous businesses throughout our community. They are taught entrepreneurial skills and shown a possible future right here in our community vs. thousands of miles away. These talented students are taught the crucial skills of networking, communication, teamwork, and what it takes to create a small business and make it profitable. Many come to the program wanting to get better at communication and to learn about business. They leave as confident young adults and aspiring businesspeople with countless new relationships in the business world of this community and beyond.

CEO's unique business model brings together students during their senior year of high school from Belleville West, Belleville East, and Althoff Catholic to learn practical business skills and put those skills to use to create their own class business the first half of the year. For 90 minutes each school day, Mrs. Siebers, a trained program facilitator, helps students discover how to become an entrepreneur, and grow into business leader in just one school year.

The classes are "home based" at one of four businesses each quarter of the year. This years' classes met at Bouse Properties, Precision Practice Management, The Edge, and Belleville's Center of Academic and Vocational Excellence (The CAVE).

The highlight of the school year is the CEO Trade Show. After nine months of developing relationships and learning about business development and processes, students have an opportunity to present their own business. It's incredible to see what they have created, to get a glimpse of the potential earning capacity of each business, and to appreciate the transformation and growth in the students over such a short period of time.

I congratulate Belleville's ninth CEO class and thank all who have made it possible including the investors, facilitators, mentors, host businesses, parents, and District 201. 
## Sophia Eggers


## **Second Session Parent's Night Out**

## **Belleville CEO Reunion**




