

CEO is made up of students in their senior year at our Belleville High Schools that apply for the class and receive a spot. The class, facilitated by Mrs. Julie Siebers, is "home based" at one of four businesses each quarter of the hear. This year, Allsup, Artigem, The EDGE, and Precision Practice Management were slated as our hosts.

The program is a year-long honors class designed to utilize the partnerships that provide an overview of business development and processes. Students had the opportunity to visit area businesses, learn from guest speakers, write business plans and start and operate their own business.

This will also necessitate the need to grow our support group of investors and mentors. We welcome your suggestions for both.

I've enjoyed working with the board members, the students, the facilitator, our partner (The Midland Institute), the mentors and the businesses that have made this program a tremendous success.


Zakary Anglin


Jason Blackmon, Jr.


